

Election of two members of Board of Management of RUHS for three years as per Section 22(1)(IV) of Rajasthan University of Health Sciences Act, 2005

Instructions for Nominees & Voters

1. The elections will be held on 18.09.2023 at the following two venues :-
 - a. **For faculty members of RUHS CMS** : - Rajasthan University of Health Sciences Campus, Room No. 202-B
 - b. **For faculty members of RUHS CDS** : RUHS College of Dental Sciences Campus, Meeting Hall, First Floor
 2. The following will be eligible for casting vote:
 - a. All the regular faculties (Professor, Associate Professor, Assistant Professor, Sr. Demonstrator/ Tutor) of constituent colleges will cast their vote for election.
 - b. The faculty members who are working on deputation (being appointed regular in Govt.) in any of the constituent college of RUHS will also eligible for vote casting.
 - c. The nominees can also cast their vote.
- Note :**
- The faculty working on UTB basis and Guest Faculty cannot cast vote for above election.
 - Senior Residents & Junior Residents cannot cast vote for election.
3. Voter is required to produce a valid identity card in original issued by the Principal of respective college at the time voting.
 4. Election will be held through secret ballot process.
 5. Each faculty can cast maximum two votes to any two nominees. A printed ballot paper will be provided to voter on which details of all the nominees will be available. The voter can cast his/her maximum two votes by stamping against the name(s) of to any of the two nominees. The voter, on his/her own will, may cast only one vote or can cast two votes.
 6. There will also a option of 'NOTA' for the voter at the end of the ballot paper which means 'None of the above'.
 7. Two Nominees who will get maximum votes will be elected to become members of Board of Management, RUHS for three years from the date of issuing the office order by RUHS.
 8. All other general accepted rules & principles of ballot paper voting & its result will be applicable.
 9. In any dispute/contradictory situation, the decision of Hon'ble Vice-Chancellor, RUHS shall be final.
